SUMMARY: Equity AUM rises for five successive years, net inflows more than double in FY25

Key observations

The Nifty, after five consecutive months of decline, bounced back smartly in Mar'25 with a 6.3% MoM gain – the highest since Jul'24. During FY25, midcaps gained 7%, outperforming largecaps and smallcaps, which rose 5% each. Mar'25 recorded FII inflows after two consecutive months of outflows. FII inflows stood at USD0.2b in Mar'25 after outflows of USD5.4b/USD8.4b in Feb/Jan'25. Conversely, domestic inflows moderated to USD4.3b in Mar'25 from USD7.4b/USD10.0b in Feb/Jan'25.

However, despite the challenges, domestic MFs saw their equity AUM rise for the fifth consecutive year to INR32.3t (+26% YoY) in FY25. AUM growth was fueled by an uptrend in market indices (Nifty: +5% YoY) and higher sales of equity schemes (at INR9,396b; +65% YoY). However, redemptions also rose 25% YoY to INR4,636b, leading to a rise in net inflows (more than double YoY) to INR4,760b in FY25 (all-time high) from INR1,971b in FY24.

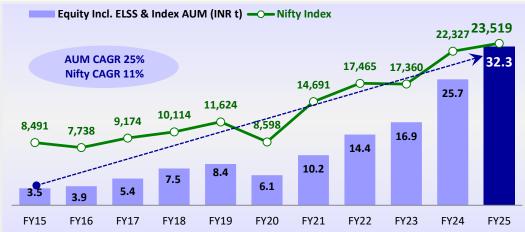
The MF industry's total AUM increased 23% YoY (INR12.3t) to INR65.7t in FY25, propelled by the growth in equity funds (INR6,660b), liquid funds (INR1,580b), other ETFs funds (INR1,156b), balanced funds (INR1,096b), and income funds (INR933b).

Investors continued to park their money in mutual funds as inflows and contributions in systematic investment plans (SIPs) stood at INR259.3b in Mar'25 (-0.3% MoM and +34.5% YoY).

A few interesting facts

- The year saw a **notable change in the sector and stock allocation of funds**. The **weight of defensives improved 30bp to 29.7%**, aided by an increase in the weights of Telecom and Healthcare, while the weights of Consumer, Technology, and Utilities moderated (*refer to page 4 for detailed charts*).
- The weight of Domestic Cyclicals too increased 30bp to 61.5%, led by Banks-Private, Retail, Insurance, Real Estate, Infrastructure, and Cement.
- Global Cyclicals' weightage declined 70bp to 8.7%, dragged down by Oil & Gas.
- Healthcare saw a rise in weight to 7.6% (+20bp YoY) in FY25, improving its position to fourth from fifth a year ago.
- Technology's position remained unchanged over the last one year, while its weightage declined by 20bp YoY to 8.5%.
- Private Banks saw a surge in weight to 18.4% (+150bp YoY).
- PSU Banks witnessed a decline in weight to 2.8% (-60bp YoY).
- Capital Goods saw a decrease in weight to 7.2% (+70bp YoY).

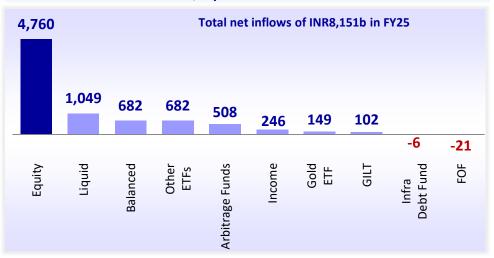
Equity AUM rises for five consecutive years to INR32.3t (+26% YoY)



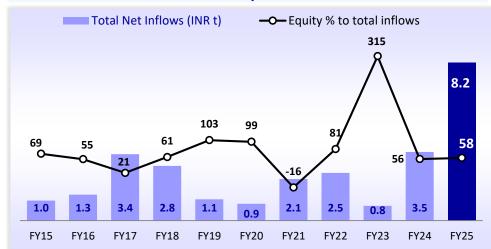

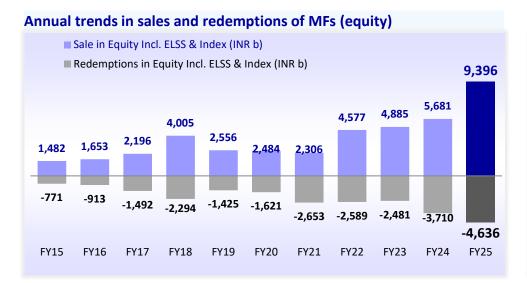

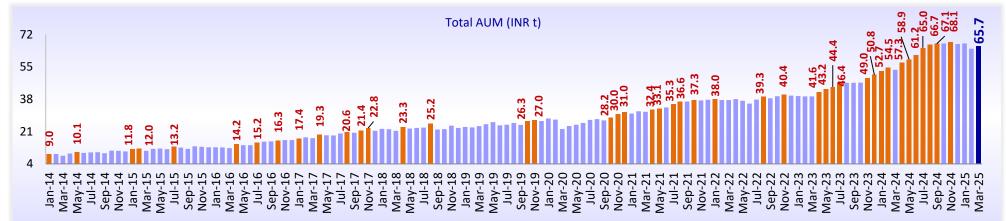

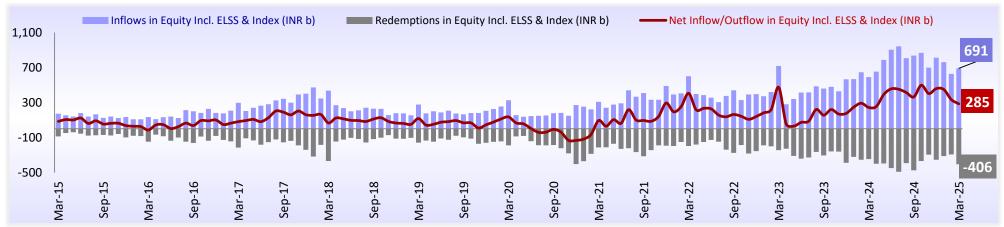
AUM: Up 1.9% MoM to INR65.7t in Mar'25; equity inflows continue to moderate

- Total AUM of the MF industry increased 1.9% MoM to INR65.7t in Mar'25, primarily led by MoM growth in AUM of equity funds (INR2,206b), other ETFs (INR528b), and balanced funds (INR279b). Conversely, AUM of liquid funds (INR1,489b) and income funds (INR359b) declined MoM.
- Equity AUM of domestic MFs (including ELSS and index funds) increased 7.3% MoM to INR32.3t in Mar'25, owing to a rise in market indices (Nifty up 6.3% MoM) and an increase in sales of equity schemes (up 9.8% MoM to INR691b). The pace of redemptions picked up to INR406b (up 37.6% MoM). Consequently, net inflows moderated for the third consecutive month in Mar'25 to INR285b vs. INR334b in Feb'25.

Top 20 funds: Value of equity MFs up 7.5% MoM and 23.5% YoY

- The total equity value of the top 20 AMCs was up 7.5% MoM (+23.5% YoY) in Mar'25 vs. a 6.3% MoM increase (+5.3% YoY) for the Nifty-50.
- Among the Top 10 funds, the highest MoM increase was seen in Nippon India Mutual Fund (+9.6%), Axis Mutual Fund (+8.3%), Kotak Mahindra Mutual Fund (+8%), DSP Mutual Fund (+7.8%), and UTI Mutual Fund (+7.5%).

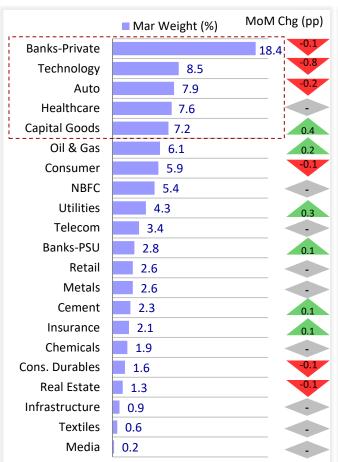

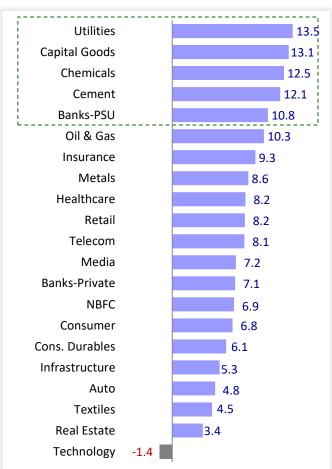
Sector-wise weightage: MoM increase seen in Capital Goods, Utilities, and Oil & Gas

- In Mar'25, MFs showed interest in Capital Goods, Utilities, Oil & Gas, PSU Banks, Cement, and Insurance, leading to a MoM rise in their weights. Conversely, Technology, Automobiles, Private Banks, Consumer, Consumer Durables, and Real Estate saw a MoM moderation in weights.
- Private Banks (18.4%) was the top sector holding for MFs in Mar'25, followed by Technology (8.5%), Automobiles (7.9%), and Healthcare (7.6%).
- Utilities, Capital Goods, Chemicals, Cement, and PSU Banks witnessed the maximum rise in value MoM.

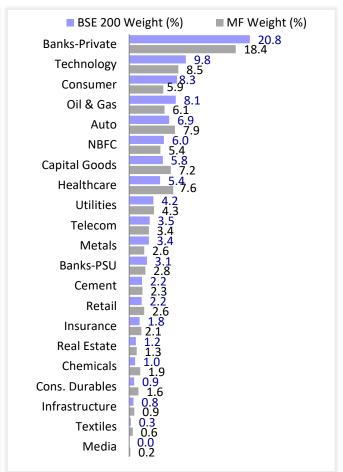
Sector allocation (%): Capital Goods, Utilities, and Oil & Gas witnessed maximum MoM increase

- The top sectors where MF ownership vs. the BSE 200 is at least 1% higher: Healthcare (17 funds over-owned), Consumer Durables (12 funds over-owned) owned), Chemicals (11 funds over-owned), Capital Goods (10 funds over-owned), and Retail (10 funds over-owned).
- The top sectors where MF ownership vs. the BSE 200 is at least 1% lower: Consumer (17 funds under-owned), Oil & Gas (17 funds under-owned), Private Banks (16 funds under-owned), Technology (12 funds under-owned), and Utilities (12 funds under-owned).

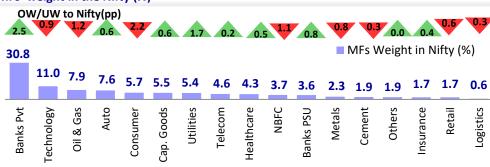

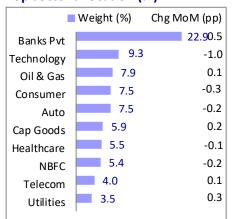
